Dear Parent/Carer

I have been asked to let you know of the proposal to decommission the School Crossing Patrollers over the lunchtime periods commencing from 7 January 2020. The crossing point used by pupils of Rowantree Primary School affected by this proposal is at Glenconnor Drive/school entrance.

The recommendations, as detailed in report number 121-206 dated 28 March 2016 and raised by the Executive Director Children and Families Service, were discussed and approved at the Dundee City Council Education Committee.

The recommendations were to:

- i. approve the proposed adoption of The Royal Society for the Prevention of Accidents (ROSPA) and Road Safety GB guidance for establishing School Crossing Patrol (SCP) points
- ii. approve the proposed procedure for dealing with SCP points that do not satisfy the criteria
- iii. remits the Executive Director of Children and Families Service to take forward future decisions in relation to the above recommendations

Tayside Contracts have carried out site surveys to determine if the ROSPA/Road Safety GB criteria is being met over the lunchtime period at the SCP point used by pupils of Rowantree Primary School. The outcome of this site survey has shown that at Glenconnor Drive/school entrance 1 pupil (accompanied) and 3 pupils (unaccompanied) used this point and therefore it does not meet the ROSPA/Road Safety GB criteria. In accordance with the committee report, the Children and Families Service is now commencing the formal consultation stage of the process for the decommissioning of the above SCP lunchtime only point.

This proposal will not impact on the school crossing patroller operating the points in the morning or afternoon.

Children and Families Service and Tayside Contracts will then assess the information and determine the course of action to be taken.

In the event of an elected member disagreeing with the proposed course of action, then they may ask for the proposal to be considered by Committee in terms of Standing Order No. 38, in which event the Executive Director of Children and Families Service and Tayside Contracts will not implement the proposal pending Committee consideration of the matter.

A letter will then be issued indicating the outcome of the formal process for decommissioning these SCP lunchtime only points.
